II. Japanese American Citizen League Presentation- Lemarquand

Bruce Shimizu with Sonoma County Japanese American Citizens League presented on the internment of Japanese Americans from Sonoma County during the WWII period. He shared personal family experiences and photos to give the audience a visual example during these times. He emphasized the long-standing impacts that it had on multiple generations of Sonoma County Japanese American community members and how prevent this experience to happen to any other ethnic group.

Resolution of The Commission on Human Rights of Sonoma County Honoring Isabel Lopez as A Champion of Human Rights

Whereas, Isabel Lopez has been a Commissioner on Human Rights (CHR) March 2021 thru March 2025, and has served with dedication and passion in various ad hoc committees, advocating for human rights and justice; and

Whereas, Isabel Lopez has consistently been a vital member of the CHR, demonstrating a strong commitment to advancing language, social, and environmental justice within our county's diverse communities, particularly for the marginalized and underserved populations, including Indigenous, Central and South-American, and non-English-speaking communities of Sonoma County; and

Whereas, Isabel has been a tireless advocate for immigrant rights and ensuring the voices of vulnerable communities are heard and uplifted; and

Whereas, Isabel has empowered and mobilized the community through the arts, direct action, and social justice advocacy, harnessing her tremendous transformative tools to foster social change, promote sustainability, and strengthen community bonds; and

Whereas, Isabel Lopez has exemplified dignity, respect, and integrity in all her duties, contributing to the betterment of Sonoma County, and showing extraordinary fortitude in the pursuit of justice, equality, and community empowerment; and

Whereas, Isabel is a shining example of the resilience, diversity, compassion, and strength that defines a Sonoma County Commissioner on Human Rights;

Therefore, be it resolved, the Sonoma County Commission on Human Rights hereby honors Commissioner Isabel Lopez for her exceptional service to the County and declares Isabel Lopez a Champion of Human Rights.

Immigration

The Commission on Human Rights reaffirms the principle that no human being is "illegal" or outside the protection of the law or exempt from receiving human rights. As defined by various immigration and ACLU organizations, the Sonoma County Commission on Human Rights declares and reaffirms:

- 1. No Human Being is Illegal
- 2. Equality and Dignity before the Law
- 3. Right to Liberty and Security of Person
- 4. Protection of Family Unity
- 5. Right to Freedom of Opinion and Expression
- 6. Right to Due and Fair Process

Immigrants in the U.S often face xenophobia, racism, backlash and dehumanization due to their place of origin. The Commission on Human Rights stands behind people who have an immigrant or an undocumented status, no human is "illegal" or can be "alien" as global citizens.

Our commission stands in support of people who are undocumented or have a mixed-status family household. Immigrants rights are human rights, which is clearly defined within the Universal Declaration on Human Rights, Convention on the Rights of a Child and by multiple human rights organizations like the ACLU.

The Commission on Human Rights condemns splitting families apart, detaining humans in detention camps and denying services to others due to their background/documentation status. We hold strongly that undocumented and documented individuals have the right to equality, security, liberty, freedom of expression, due process and to keep our families together. The Sonoma County Commission on Human Rights stands in solidarity and allyship with immigrant, first-generation and mixed-status families who live in fear of deportation or retaliation due to their background.

Additionally, we reaffirm and stand with the Sonoma County Board of Supervisors, who have "pledged to protect the civil rights of the County's immigrants to the fullest extent provided by the law. The Board also reaffirmed the County's commitment to abide by state laws adopted by the California Legislature that ensure law enforcement services, schools, health care facilities, courts and other public agencies are accessible to every person in California, regardless of immigration status." <u>https://sonomacounty.ca.gov/administrative-support-and-fiscal-services/county-administrators-office/projects/support-for-immigrant-communities</u>
