## III. State of California Civil Rights Conflict Resolution Unit Presentation

Marquez Equalibria with the Conflict Resolution Unit presented on the creation of the unit under the States' Civil Rights Department. This unit was created after the pandemic during the hype of hate and discrimination. They help designing conflict resolution processes, facilitating community engagement processes, education and training, technical consultations, and mediating community dispute. They have a hate resources hot line where they can report an issue and be connect to people who can answer their questions. The Commission shared that they have a similar project- The Visibility Project 2.0.

- 2. Chair Phillips announced that nominations for Officers are occurring on May 27, 2025 as well as the strategic planning session.
- 3. Chair Phillips reminded to attend the Dry Creek Rancheria invitation to ribbon cutting ceremony & grand opening of Bi'du Khaale Elder Community and MMIP awareness and healing event on May 3rd, 2025 from 9am -2pm at1609 Nopo Way, Cloverdale, CA 95425.

## VIII. Ad Hoc Committee and Project Committee Updates

- 1. Sonoma County Human Rights Visibility Project 2.0 shared data from the survey. The survey respondents ages 35-44 years old were the majority and Hispanics/Latinx individuals reported the most. From 2020-2025 only 44 individuals reported human rights incidence. Some of the human rights incidences were xenophobia at 22%, followed by personal safety, law, enforcement, LGBTQI, employment and labor, criminal justice, system, emotional abuse, homelessness, housing, sexual abuse, and family court healthcare. There was a pattern in incidence. October 17-31<sup>st</sup> had the most cases reported and from 12pm-6pm regardless of the year.
- 2. Housing and Homelessness didn't have anything to report.
- 3. Disability Justice didn't have anything to report.
- 4. Racial Equity and Social Justice Framework didn't have anything to report.
- 5. Adult Prom is finalizing their flyer. The adult prom will be on Sunday, June 22, 2025, at the Arlene Francis Center with no fiscal sponsor.
- 6. Youth Commission on Human Rights is having their final meeting on April 26<sup>th,</sup> and they will have their Fentanyl Awareness event at 2-3:30pm. They will be having their Gaza Education Day at the Arlene Francis Center on May 6<sup>th</sup>. They presented at the Santa Rosa Junior College Social Justice Conference. The teens were talking at the teens at the conference.

#### 1. Pride Resolution

Chair Phillips read the resolution honoring June 2025 as Pride Month is Sonoma County. The Commission mentioned to be consistent on the usage of LGBTQIA2S+ and to correct 57<sup>th</sup> anniversary to 56<sup>th</sup> anniversary. This resolution will be presented at the Board of Supervisors meeting on June 3, 2025 at 1:30pm. Motion to approve the resolution with the recommended edits.

#### 4. Pledge Invitation

The Peace & Justice Center invited the Commission to support their Community United to Resist Fascism or (CURF) Statement of Purpose. Chair Phillips led the discussion on whether it was appropriate for the Commission to support this. Commissioner Thayer and Sofranko voiced their concerns that the statement is not addressing the systemic problems that has been going on for years. The statement could have been written better. The commission will be bringing their own statement forward; however, they did agree that it was in their scope of duty to support the statement because the call to action items on the statement are human rights issues. The statement has a clear expectation for the Commission to provide support. Motion to approve the statement and add the Commission's name on the pledge.

## **COMMISSION ON HUMAN RIGHTS – WORK PLAN SECOND DRAFT**

Name of the ad hoc: Workshop Discussion on the UDHR among Members of the Incarcerated Population

Description of the project/ ad hoc: 2 to 3 hour workshop in one or two sessions to read, interpret, and discuss the meaning and implications of the UDHR among an incarcerated population to include (if possible) residents of the SC jail, officers, volunteers, and family members.

### Objective:

This is designed to be a philosophical discussion.

The question we are asking is how the UCHR applies to Sonoma County. Since the purpose of the Sonoma County Human Rights Commission is to "promote better relations between all people in Sonoma County through education, advocacy, communication and initiation of action," this invites the Sonoma County incarcerated population to be included in the conversation as they are part of our Sonoma County community. Our discussion will explore whether or not the declaration of human rights represents a personal system of belief or a social system of actions. How might we interpret and evaluate individual articles in the Declaration of Human Rights? Are there human rights omitted?

It is not a question as to who or what country adheres to or disregards the Universal Document of Human Rights, or a question about human rights while in captivity, although both questions are impossible to ignore. It is a question about the state of Human Rights in Sonoma County, and how individual beliefs may affect another person's belief, in turn affecting a system of beliefs. Any declaration of human right is no doubt an ideal. Can an aspirational set of beliefs be understood and promoted to foster "the recognition of and appreciation for the diverse community" (Sonoma County Commission on Human Rights)?
