

Stop Data Collection 2024

The following are the required data fields to be collected as of January 1, 2024 following the recent RIPA regulatory changes. This document is meant to serve as a sample of the required data fields.

Reason for stop (select one primary reason for the stop)

- Determine whether the student violated school policy (only applicable under certain conditions)
- The person stopped is a passenger in a vehicle (only applicable under certain conditions)
- The stopped person is inside a residence, where an officer was executing a search or arrest warrant naming or identifying another person, conducting a search pursuant to a condition of another person's parole, probation, PRCS, or mandatory supervision, or conducting a compliance check on another person under home detention or house arrest. (only applicable under certain conditions)
