#### Call to Order

## V. Old Business

A. Second reading for Sonoma County Regional Parks Foundation for more bear-proof recycle trash bins. Sheila Murphy present via Zoom. Beth Lamb concerned; amount is larger than what commission usually grants. This is for North Coast Region, replacing four non-bear-proof trash cans at coastal access points at Sea Ranch area and replacing seven food lockers at Gualala Point Regional Park. Bears have started to show up at this campground. Sheila added they have implemented bear resistant infrastructure since receiving last grant. They have put in bear-proof

trash cans at Chanslor Ranch, implemented first trial run of bear resistant dumpsters in Sonoma County at Gualala Point and Stillwater Cove. Melissa appreciates generosity and continued support and looks forward to submitting report upon completion.

**Action:** A motion was made by David Cook to accept this proposal for **Grant #227**; motion was seconded by Jeff Holden.

Passed with: 7 ayes, 0 nays, 4 absent.

B. Second reading for Susan Kirks, Madrone Audubon Society for additional funds for West 9<sup>th</sup> Street project. Revised application and 2021 newsletter received.

**Action:** A motion was made by Beth Lamb to accept this proposal for **Grant #228**; motion was seconded by Harry Hubbell.
